The Board of Directors Report:

Drop-Ins Detailed Report – there will be no carryover to Roth Swiss.

Soloway KO Motion (Passed) – Dennis Carman gave detailed report There will be a 2 Session Swiss qualifying. Seeding position will be 75% from the Swiss standing and 25% from regular seeding points. The event will start in the fall of 2019.

There was a side discussion of a plan to run Swiss and round-robin qualifiers for Regional (and Sectional?) KO events.

There was a suggestion of a B-A-M movement by Chris Compton.

For small brackets – The BOD is trying 3 matches non-reduced points, additional points for 4 matches in 6-month pilot.

Convention Chart Subcommittee - Russ Jones Motion by Board deferred to Philadelphia – but no problems expected Bridge Committee is reviewing charts in detail, expect few changes. New charts will probably take effect for Honolulu.

Management must deal with implementation logistics, such as education, etc.

There was discussion of possible BOD motion to move IMP Pairs in the spring to Sunday then new Open Pair starts Friday.

Tom Carmichael suggested to move IMP Pairs to Saturday.

There was comment that younger players have nothing on Monday if not playing Vanderbilt.

There was a suggestion of 3-day swiss in the spring.

Both Swiss and Pairs will get rewarded for gold rush tables. Anticipate switching Swiss awards to strength of field in 2018.
