### Notes

1. The March minutes were approved
2. Recap of NAP changes from Board of Directors
  - To take effect at Spring 2026 NABC
  - Need to find place in schedule for 4th strat
  - Open, 6000, 3000, 750
  - Debate about whether 0-750 should exclude Life Masters
3. Advisory Council Report
  - For NAP's/GNT's, consider strata-fighting it
  - Helps people get used to idea of playing up
  - Concerns about desire of "X" players to play against those in "A"
  - Allows smaller districts to run an "event"
4. Trick 1 Proposal - no changes from previous meeting, Sol Weinstein to follow up with Jeff Ford
5. Grand Life Master proposal from previous meeting rejected by Board of Directors with request for a more comprehensive proposal.
  - Discussion on whether events should qualify based on table count or prestige
  - Proposed new policy: At any trials event with no upper age limit that qualifies the winner to play in a world championship event the winning team will be made eligible for Grand Life Master status provided that there is an in-person finals with at least six teams participating.
  - Above policy passed with none opposed.
6. Consensus of the committee was that there should not be a way to qualify for Grand Life Master via accumulation of high finishes without winning an NABC+ event.
7. Discussion of Swiss with replays postponed until next meeting

8. Conditions for KO/Swiss in limited events at NABCs - reducing number of boards or number of matches
  - There is anecdotal evidence that players would prefer shorter matches or sessions, e.g. a session of 3 matches of 9 boards.
  - Discussion of role of stamina in national events
  - Directors pre-set the tables for a certain number of boards and if it's frequently changed it's harder to set up efficiently
  - No concrete proposal made
9. Correction periods and morning starts
  - Current cutoff is 9:00 AM the next day which makes it hard to validate and find players in time for event start
  - Proposal: Create a submission website for score corrections. Include a QR code or link in the daily bulletins. Change deadline to midnight for submissions.
  - Above proposal passed with none opposed (pending ability to create such a site).
10. Conditions for Reisinger - consider changing to play two stanzas in each session so teams have more flexibility for balancing play time
  - Jeff Ford and Matt Koltnow to discuss logistics
11. Appeal without Merit Penalties
  - McKenzie Myers working on a proposal
  - Currently a problem with frivolous appeals especially in KO matches since the worst that happens is you lose a match you already lost
  - Owen Lien suggested 2 warnings in 2 years as a threshold for penalty
  - Doug Doub to coordinate with McKenzie
12. Intermediate Convention Chart
  - Committee against adding a fifth chart
  - Lee Lin to create proposal for potential loosening of Basic+ chart to achieve similar goals
13. Slow Play discussion postponed to next meeting
  - Directors said that current staffing levels make enforcement difficult as does lack of clear directive from C+C committee
14. Drop-ins from 2nd day of 3-day Life Master Pairs to finals of 2-day NABC+ pairs
  - Sol Weinstein voiced concern that in the past drop-ins were upset if they didn't get carryover and qualifiers were upset if some drop-ins started ahead of them.
  - Logistics are more difficult with an unknown number of pairs dropping in.
  - David Grainger pointed out this is an ideal event for drop-ins as both events have same format and same scoring
  - Committee split on whether its a good idea or not, no official proposal made.
