At the Houston 2009 Spring meeting the Board of Governors asked the Board of Directors to reconsider Item 091-178 Schedule of Nationally Rated Events at NABCs. The following was passed at the Washington 2009 Summer meeting.

## **Item 092-36: Schedule of Nationally Rated Events at NABCs (091-178)**

Item 091-178 is amended as follows:

- A. The Silodor Open Pairs is moved to Thursday Friday (just before the last weekend) of the Spring NABC, replacing the IMP pairs.
- B. The IMP pairs is moved to the first Friday Saturday at the Spring NABC, replacing the Silodor pairs.
- C. The masterpoint award for 1<sup>st</sup> overall in the IMP pairs is reduced from 125 to 100.
