# **Motions for Reconsideration**

Moved by Richard Popper, District 4, and seconded that the ACBL Board of Directors reconsider Item 053-140, Spring NABC in Memphis TN.

Moved by Leo Weniger, District 1, and seconded that the ACBL Board of Directors reconsider Item 053-141, 2013 Fall NABC in Montreal PQ, and ask that local personnel assist with the negotiations.

# **New Business**

Moved by Rand Pinsky, District 23, and seconded that the following sense of the Board of Governors be conveyed to the Board of Directors: if two districts merge voluntarily, then concessions should be made for participation in the GNT and NAP events.

Moved by Jan Nathan, District 23, and seconded that senior events may be stratified by age or by masterpoints but not both. Stratification is to be limited to not more than three stratas. If stratified by age, the younger person or the youngest member of the team will determine the strata. The "stratified by age" masterpoint awards will be 80% for 55+, 75% for 65+ and 60% for 75+.

#### Motion failed.

Moved by Corrine Kirkham, District 22, and seconded that all national events at NABC's will have consistent starting times throughout the length of the event. There shall be an exception for the final Sunday of an NABC.

# Carried.

Moved by Barbara Seagram, District 2, and seconded, that because the ACBL has jurisdiction over all of North America and Bermuda that the Board of Directors consider changing the name of the organization to the North American Contract Bridge League.
