

# **ACBL District 18**

## **2019-2020 North American Pairs Conditions of Contest**

### A. General

1. National Conditions:

The 2019-2020 North American Pairs (NAP) Conditions of Contest as published by the ACBL

[www.acbl.org/.../conditions-of-contest/conditions-of-contest-north-american-pairs](http://www.acbl.org/.../conditions-of-contest/conditions-of-contest-north-american-pairs)) govern this competition. These ACBL District 18 (D18) Conditions of Contest cover circumstances that are unique to D18 and clarify options available under the National Conditions of Contest.

2. Participation:

To advance beyond the club level to the D18 Finals, a player must be a member in good standing of both the ACBL and its geographical division of D18.

3. District Coordinator:

### B. Club Stage

Club qualifying games will be conducted in June, July, and August of 2019 as per the ACBL National Conditions of Contest. Clubs may hold two NAP games per each sanctioned session each of those months. The use of Bridge conventions is also as per the National Conditions of Contest. Club managers must submit the ACBL Score game files (or equivalent) to the D18 Coordinator via e-mail by the first week of September.

### C. Unit Level

The Unit stage of the NAP competition will **NOT** be conducted in D18. Players who qualify at the club level can advance **directly** to the D18 Finals.

### D. District Finals

1. Tournament Eligibility:

a) Masterpoint (MP) limits for each flight are as of the ACBL 2019 June MP cycle which is run on May 6, 2019:

Flight A – Open to any player

Flight B – Players with less than 2500 MPs

Flight C – Non-Life Masters with less than 500 MPs

b) Players **MUST** have qualified at the club level to play in the District Final

2. Event Date and Location:

D18 will have one site for the District Final. It will be played in Butte, Montana on Saturday, September 21, 2019, at the Butte Fall Regional which will be held at the Copper King Hotel and Convention Center, 4655 Harrison Ave., (406)565-5001. The sessions are at 10:00 am and 3:00 pm.

3. Event Format:

All three flights in the D18 NAP Finals will be conducted as a one day, two session, play through event.

4. Entry Fees:

The entry fees will be the same as the Butte Regional entry fees.

5. Bridge Conventions:

The ACBL Basic Convention Chart applies for Flight C, the Basic+ Convention Chart for Flight B, and the Open+ Convention Chart for Flight A.

6. Advancement to the North American Finals:

The top three eligible pairs in Flight A, and the top four eligible pairs in Flights B & C qualify to the national finals, which will be held at the 2020 Spring NABC in Columbus, Ohio. Pairs qualifying to the national finals qualify as a pair and no new partnerships may be formed.

## E. Subsidies

Travel expense subsidies for those who qualify for participation in the National Finals are administered by the ACBL. D18 will not provide any additional subsidies.

## F. Contingencies

The Director in Charge (DIC) will resolve all contingencies or ambiguities relating to the format or playing conditions of the D18 finals that are not specifically addressed by these conditions.
