



## D21 District 2024-2025 North American Pairs Conditions of Contest:

D21 District Conditions of Contest will be played according to the ACBL [2024-2025 North American Pairs Conditions of Contest](#) with the following elections permitted by these Conditions:

1. Unit Level Qualifying games will not be required for participation in D21 District Level Qualifying games. Units within the District 21 may still hold non-qualifying Unit finals at their own discretion before November 30<sup>th</sup>. However, the following requirements from the ACBL Unit Level Participation will be applied to the District Level:
  - 1.1. Both players must be members of the parent district.
  - 1.2. Both players must have qualified in an NAP club game.
  - 1.3. Any player that qualified in any club may play with any other qualified player in any Unit in their District. Each player must be a member of a Unit in their parent District.
  - 1.4. Each player must be an ACBL member in good standing who has not been placed in an ineligible status by an ACBL disciplinary body.
  - 1.5. A player whose membership dues are paid prior to District competition is deemed to be a paid member at the time of entry. **ONLY PAID MEMBERS, INCLUDING LIFE MASTERS WITH LIFE MEMBER STATUS, WHOSE DUES OR FEES ARE CURRENT PRIOR TO THE UNIT STAGE, MAY PARTICIPATE BEYOND THE CLUB LEVEL.**

2. There is no pre-registration for any of the events. The ACBL generated [NAP Qualifiers](#) list will be used to determine eligibility to play in the D21 NAP District Level Qualification games.
  - Please note that in the past, there have been omissions in the list. If you believe that you are wrongly left off this list, then please email [jcoke@yahoo.com](mailto:jcoke@yahoo.com) to appeal. Appeals must be filed one week before the event. I will need to know your ACBL number plus the club and date of the NAP game that you qualified. (Please note that you may be disqualified if your dues are not paid or if you are under an ACBL disciplinary action.)
  
3. The **D21 flight A District Qualification** will be played at the Monterey Clambake Regional on the following schedule:

Saturday, January 11, 2024, at 10 AM & 3 PM  
Sunday, January 12, 2024, at 9:30 AM & after a short lunch break

  - The Qualification will be conducted as a four session event where the first two sessions on Saturday qualify approximately 50% of the field for the final two sessions on Sunday.
  
4. The **D21 flight B District Qualification** (<2500 MPs) will be played at the Monterey Clambake Regional on the following schedule:

Sunday, January 12, 2024, at 9:30 AM & after a short lunch break

  - The Qualification will be played as a two session play through event.
  
5. The **D21 flight C District Qualification** (<500 MPs and not a Life Master) will be played at the Monterey Clambake Regional on the following schedule:

Saturday, January 11, 2024, at 10 AM & 3 PM

  - The Qualification will be played as a two session play through event.
  
6. Entry fees for all NAP D21 District Level Qualification games will be \$17 per session.
