2004: The Year of the Volunteer

ACBL president Bruce Reeve got involved early in his bridge career as a volunteer, and he wants 2004 to be "The Year of the Volunteer."

Reeve recalls moving to the Lynchburg VA area in the early Seventies and going to the local bridge club. "I asked if there was anything I could do to help and they asked if my wife and I would run their sectional tournament. They also asked if I would be on their board and run their GNOT. I then asked if anyone did anything and they said, 'You're the first person who's volunteered in years'."

The 'first person' continued to volunteer — club, unit and district boards. A unit board in the Virginia Beach VA area had 36 members. "When my company transferred me out of the area, they voted to replace me with a vacancy – that was the smartest board I've ever been on."

Reeve grew up in Toms River NJ. "My parents wanted me to go to an Ivy League school and I wanted to go to the University of Miami." The

Bayou Classic: get your wristband

Grambling and Southern football fans will be flooding the streets and hotels of New Orleans this weekend. All area hotels will require wristbands to identify guests only for admittance to their hotels. The Marriott will secure the Canal Street doors at 6 p.m. on Friday, and the only entrance will be at the garage entrance on the Chartres Street side of the hotel.

All bridge players who are not staying at the Marriott will be able to pick up a security wristband in the hotel lobby beginning today at 9 a.m. If you are unable to pick up a wristband prior to 6 p.m. on Friday, you will simply need to identify yourself as a bridge player to hotel security staff at the security station that will be set up outside the revolving doors at the garage entrance.

Wristbands will be delivered to guest rooms in the Marriott Hotel on Thursday evening.

Colchamiro, Lynch in Senior KO final

Mel Colchamiro's team surprised an all-star team which had Edith Rosenkranz as non-playing captain in one of the semifinal matches in the Senior Knockout Teams. They'll play the team headed by npc Carolyn Lynch in today's 64-board final.

The Lynch team had an easy time yesterday. They took a 68-IMP lead in the first quarter against the team captained by Murray Melton. They increased their lead over the next 16 boards to 88, and the Melton team decided not to play the second half

The Lynch team consists of six players who won bronze medals in the world championships in Monte Carlo earlier this month. Bobby Wolff and Dan Morse were on the team that finished third in the Bermuda Bowl. Dennis Dawson, Clement Jackson, John Sutherlin and John Mohan finished third in the Senior Bowl. Playing with Melton were Simon Kantar, George Tornay and Armand Barfus.

Only one of the players on the three leading pairs in the Blue Ribbon Pairs is an American, but the American is leading the field with a Norwegian partner. He is Michael Seamon of Miami Beach, and he is playing with Geir Helgemo of Norway.

They have a small lead – about five points on a 25 top – over Nafiz Zorlu and Salvador Assael of Turkey.

Another transnational pair is in third place, approximately 19 points further back – Jan Svendsen of England and Erik Saelensminde of Norway.

A field of 104 pairs will contest today's two-session final with a 51 top.

Where did the spade king go?

Where was the ♠K? Bart Bramley, the declarer as North, thought East had it for his spade opening lead. East thought Bramley had it because partner did not play it on the opening lead. This is the deal from the second final session of the Life Master Pairs.

East led the AJ, and West ducked, which enabled Bramley to win with the queen. Why did West duck? He had a good reason. He thought his partner was probably leading from a five-card suit. He expected to get in with a red ace and drive out the AA with his king. Then when he got in with his other red ace he could cross to partner's good spades to beat the contract.

But it didn't work out that way – not at all!

After winning the first trick with the $\triangle Q$, Bramley did some thinking. Since East had the ♠K (!), he placed the ♣K with West. So he led a club and went up with the ace instead of finessing. He led a diamond to the king and led the \$\.\J. He was devastated when he saw East produce the king. He knew he was headed for a big set.

But remember, East thought Bramley had the ♠K, so he thought there was no future in that suit. He switched to the ♥9! Bramley was alive again - he could take three clubs, three hearts, two spades and a diamond for plus 150. That felt good - until he saw his matchpoint score. He and Sidney Lazard got only 43 of 90. Why? Well, most players didn't make a takeout double with the South hand and East-West wound up playing 2. When they misguessed the spades they had to lose two spades, two hearts, two clubs and a diamond for minus 200.

On the previous round, Bramley faced a serious challenge on this deal

Bramley made a somewhat unusual takeout double at his first turn. He wasn't too happy when Lazard cuebid 4♦, but he felt better when West doubled. "I could pass and leave the decision to Sidney," he said. But Lazard didn't cooperate – he redoubled. So Bramley had to make the choice after all, and he bid $4 \heartsuit$ – not exactly an elegant contract.

The defense started with two rounds of diamonds. Bramley wasn't happy about ruffing in the long hand, but what else could he do? He led a trump to the 10 and East's jack He ruffed the diamond return and led a spade to the queen and followed with a second spade to the jack, king and ace. West did not work out that partner must have a doubleton spade and could ruff a third round. Instead she switched to a club to dummy's queen. Next came a heart to the king and a club to the jack. Bramley cashed the trump ace, feeling quite relieved as the suit split 3-3.

Then he ran his clubs, and West was squeezed in spades and diamonds. When West decided to hold spades, Bramley took his 10th trick with the unlikely ◆10.

Being famous is fun



Gene Benedict and Jonathan Steinberg wasted no time in getting to a grand slam on this deal from the first qualifying session of the Blue Ribbon Pairs.

Benedict won the opening heart lead in his hand and ran four trumps. This put tremendous pressure on South who had to protect all three side suits – note North's yarborough. This was the position as Benedict was about to cash his fifth trump:



Benedict pitched the *J on the fifth spade, and then it was South's turn. What could he do? If he threw a heart the hearts would run. The same was true of diamonds. He could blank the *K, but chances are Benedict would read that.

He actually blanked the ♣K, but Benedict had an answer to that – he led a club to the ace to check. When the king fell he had his 13th trick.

A defensive gem

Rarely do we come across a defensive gem like this one. Bart Bramley and Sidney Lazard combined to defeat a contract that looked like a sure make. The deal occurred in the first qualifying session of the Blue Ribbon Pairs. No doubt it will be a candidate for the Best Defense award given annually by the International Bridge Press Association.

Despite partner's diamond raise, Lazard stayed away from the •A opening lead, which would have given away a trick. A club opening lead would have cleared up the spots in that suit for declarer. Instead Lazard chose to start with a trump, a good choice.

Declarer won and led the \$49, a move he would later regret. Lazard covered with the queen and dummy's king won. Declarer crossed back to his hand with a club. He switched to the \$10 and Lazard covered as Bramley contributed the 8.

Lazard looked at that 8. He knew his partner had three spades – where was the 7? Apparently the 8 was a positive signal — it was the highest spade still outstanding — so Lazard placed his partner with the 7. Suiting thought to action, he led his low spade and was gratified to see Bramley win with the 7. That enabled Bramley to lead the \$\times Q\$. Declarer was fixed. If he ducked, Bramley would switch to a diamond. If he took the king, he would eventually have to play another club, and Bramley had the jack-9 over dummy's 10-8.

What a combination! Bramley had to think of playing the \$8 instead of the 7 that you and I would have followed with. Then Lazard had to read why Bramley had played the 8 and then follow through on his conclusion.

If declarer had started with the \(\&\) 6 at trick two instead of the 9, we wouldn't have had this wonderful story to tell.

Silver Life Master

Bill Nabors of Colorado Springs passed the 1000-point mark in the bracketed knockouts. He came to New Orleans needing 50 points, and he already has earned more than that in knockout events. His partner is Dave Appel of Denver, and their teammates are Neil Hunter and Anita Paulson of Santa Fe.

As North, how many trump tricks should you figure to score with your doubleton \$9 6? Partner's \$\times Q\$ is in the pocket for declarer - not a good sign.

You (North) led the ♥3, unimaginatively. Declarer wins his ace and leads the ♦9. You duck, stoically, win the next diamond and finally play the •K and a club to the jack. The •A comes back, forcing West to ruff low and you score your •6.

Now you play back a heart. Declarer ruffs in dummy and has reached this position:

Declarer leads the \bigstar 10 and partner thoughtfully ruffs with the \bigstar 8, forcing the \bigstar K. Declarer ruffs his \bigstar 6 in dummy and leads the \bigstar Q, ruffed with the \bigstar 4 and overruffed with the \bigstar 5.

Declarer would do best to lead out the ♠A and concede trick 13 to your ♥10. Instead he ruffs his fourth heart with the ♠J, overruffed with the ♠Q. A club back promotes your ♠9.

The defense has scored three trump tricks to set 2 .

Turkey far from being a sure thing

At present the World Team Olympiad is still set for Instanbul, Turkey, as was noted in the feature article in yesterday's Daily Bulletin.

Terrorist activities could force the World Bridge Federation to seek a different location, just as it was forced to do in 2000 when the world championships had been scheduled for Bali, Indonesia.

Recent events in Turkey have not been conducive to inducing players from around the world to visit that nation.

Convincing ploy

The spade stoppers were a bit thin on this deal from the Senior Knockout Teams. However, Fred Hamilton found his way after getting a club opening lead against 3NT. He made an unusual play, and it was convincing enough to fatally mislead the defense.

Well, what would you do after a club opening lead? Most declarers would ride it around to their queen. Not Hamilton. He went up with dummy's ace and led a heart to the king and ace. Consider West's problem. It certainly appears that his partner has the \$Q, else why would Hamilton go up with the ace? So he continued with a second club!

This time Hamilton led it ride to his now singleton queen, and moments later he claimed 3NT with an overtrick.

At the other table, declarer, also in 3NT, let the club lead run to his queen and ran five diamond tricks. When West finally gained the lead with the ♥A, there had been some confusion in the discarding. West switched to the ♣K, leading to a push the hard way at plus 630

compromise choice: Wake Forest University in Winston-Salem NC.

He played canasta and cribbage growing up and competed in his first duplicate at Wake Forest. "The first time, neither of us – my partner or I – had a very good time. One lady laughed at our ineptitude. We made up our minds that the only reason we were going back was to beat her."

In the late Sixties, there were lots of college students playing on campuses and in clubs. "I think it's a good sign that lots of college kids have started playing again in our clubs and tournaments. Maybe we're starting to turn the corner."

Reeve's early mentor was Loreen Mitchell. "She was a lady who ran bridge clubs in several areas, including South Dakota and North Carolina. She befriended a lot of college students and she helped develop a lot of pretty good players including Allen Hawkins and my wife. It's a shame it didn't take on me," he says with a laugh.

Reeve, however, had earned more than 8,000 masterpoints and teaches and plays professionally.

"Bridge has been an important part of my life as I moved to many cities. I had a circle of friends through bridge and I could see old friends at tournaments"

As for 2004, Reeve plans lots of traveling – to tournaments such as Albuquerque NM and Halifax NS, places that don't generally attract ACBL presidents.

He's also planning two major changes:

- 1. All Junior activities will be under one committee, rather than several committees. "It is important that we raise the number of Juniors who are playing and who are involved in bridge.
- 2. An expanded committee will be responsible for zonal and international affairs, combining world bridge and relations with our federations.

"We will have the largest marketing budget we have ever had and that total program can succeed only with the help of our membership. We have an opportunity now with the baby-boomer generation to develop a new group of players who have been competitive in golf, tennis and other physical activities that they're aging out of. We cannot allow this opportunity to be missed."

Another interest is expanding ACBL bridge in Mexico. "We had 500 Spanish translations of the *Club Series* printed. About 90% are still in our warehouse. I think we have a lot of opportunity to expand bridge in Mexico."

"This is the year of the volunteer" and also the 40th anniversary of John F. Kennedy's assassination. Kennedy's famous "ask not what your country can do for you, ask what you can do for your country" applies to bridge and its membership.

"I truly believe the members have a responsibility to raise their hands and say, 'What can I do?'

"The responsibility also lies with the clubs, units and districts to ask new people to participate. Our studies have shown that one major reason that people drop out of bridge in their first couple of years is that their partners either become ill or move away."

"If we involve new people, they would have a circle of friends rather than depending on one partner.

"They may never became great bridge players but they sure could bake some mean brownies or chocolate-chip cookies."

The success of District 7 and the Mid-Atlantic Conference is due to a "tremendous amount of qualified volunteers. Most people will do a job for

a couple of years and then turn it over to another volunteer. The Mid-Atlantic has done a tremendous amount with the I/N program — it is probably the #1 reason for our success."

Reeve had been chairman of the Raleigh regional four different times. His wife, Sue, has provided the basis that allowed his involvement in bridge activities. She is a Gold Life Master with more than 4,000 masterpoints.

District 7 has been the annual ACBL-wide leader in funds raised during Junior Month. "District 7 people like to play bridge and they love masterpoints – the opportunity to support Juniors and win extra masterpoints is what makes the District a leader."

He noted last year's visit to the AARP convention. "The response was overwhelming. We need more of these activities in 2004.

"It's an old cliche but the squeaky wheel gets the grease. Many of our members are members of other organization. Ask the Elks, AARP, country clubs, whatever for more bridge activities and articles.

"You can be a squeaky wheel."

Her job as a stewardess for American Airlines had much to do with her bridge activities. "When I applied for the job, I told them I wanted to be a stewardess so I could go to bridge tournaments. The plan worked! I was a stewardess for 37 years."

She won her world gold medal in the Women's Team Olympiad in Maastricht, the Netherlands in 2000. In fact, both Sutherlins were champions there – her husband John won the Transnational World Senior Teams crown.

Her other successes at the world level include a second in the World Mixed Pairs with her husband, a fourth in the Venice Cup and a fourth in the Women's Pairs.

She has won seven North American championships, three of them with Petra Hamman. Her present partner is Karen Allison, but she had many good games with Mike Lawrence and Ron van der Porten some years ago.

She has been active in bridge administration, serving as a member of the ACBL Laws Commission, Competition and Conventions Committee and Ethical Oversight Committee. She served as co-chair of the National Appeals Committee 1990-96.

She represented District 21 on the Board of Governors 1988-91 and District 16 1993-96.

Convention card reminder

Each player is required to have a convention card filled out legibly and on the table throughout a session. Both cards of a partnership must be identical and include the first and last names of each member of the partnership.

If a director determines that neither player has a substantially completed card, the partnership may play only Standard American Yellow Card conventions and may use only standard carding. This restriction may be lifted only at the beginning of a subsequent round after convention cards have been properly prepared and approved by the director. Further, the partnership will receive a 1/6 board matchpoint penalty for each board played, commencing with the next round and continuing until the restriction is lifted. In IMP team games, penalties shall be at the discretion of the director.

If the director determines the partnership has at least one substantially completed convention card but has not fully complied with ACBL regulations, the director may give warnings or assign such penalties as he deems to be appropriate under the

The elusive 10th trick

This deal from the second qualifying session of the Blue Ribbon Pairs produced several interesting challenges for declarer and the defenders.



3NT is where South wants to be. He has nine top tricks but can he produce a 10th?

West leads a spade to East's ace and now a heart shift does no good. South covers and West can't continue hearts, so declarer can simply give up a club.

Say East continues the AQ at trick two. If South ducks, East does best to shift to a heart and now the defense prevails in the battle for a fourth trick.

But if, as happened at our table, East wins the AQ to play a third spade, watch what happens when declarer takes the top clubs and finds the bad news.



You'll notice that West still has to discard. If he throws a diamond, declarer cashes four diamonds and leads the ♥8 to his ♥9, endplaying West. If West pitches a heart, declarer ducks a heart and sets up that suit. Either way, declarer has his 10th trick.

Attendance: 9370 tables

Mr. 30 IMPs

My partner, Hansford Rowe, has earned a new nickname – Mr. 30 IMPs. Here is the deal from the Sunday-Monday Bracketed Knockout Teams that produced the nickname.

I held

and opened a strong, artificial 2 . I was pleasantly surprised to hear Hansford's response of 2 . Envisaging a holding akin to six hearts, a doubleton diamond and the K, I closed the auction with a leap to 7 .

Hansford's actual differed more than slightly from what I expected. He held:

Well, maybe the auction is not everyone's choice but Hansford shone in the play. He won the opening spade lead, pitching a diamond from dummy, and cashed the *K.

He cashed two rounds of hearts, with the suit splitting 2-2. Next he cashed the ◆A K, with that suit splitting 3-1. Then he played the ♣A Q, pitching diamonds from his hand, as each opponent followed. A fourth club was ruffed in hand.

A spade ruff to dummy allowed Hansford to pitch a third diamond from hand on the long club. He claimed the remaining tricks on a crossruff.

Now about that nickname, "Mr. 30 IMPs" – our teammates defended 4♥ and scored minus 710. Our plus 2210 produced a 17-IMP swing for our team. Had Hansford failed a trick in 7♥, we would have lost 13 IMPs on the board – a swing of 30 IMPs. As the match developed, we won by more than 30 IMPs but Hansford's play highlighted the match and earned him his new nickname.

As an aside, the deal represented an interesting application of one of Barry Crane's rules, as recently referenced by Zeke Jabbour in his *Bulletin* article: Never bid a grand slam in a team game.

Had I bid 6♥ and not 7♥, we would have won only four fewer IMPs on the board (13 instead of 17 IMPs) and would not been subjected to the risk of taking only 12 tricks.

Tough customer

Three of the players had three cards left, but the fourth lady had only two. The director started to try to determine when she had played twice to a trick, but she stopped him. "I'm playing it right! They just can't keep up with me."



'Last board' syndrome

You all know what "last board" syndrome is: you rush to get out and score up and blow a contract you should make.

On the last board of the quarterfinal round of the Senior Knockout Teams, Fred Hamilton was playing what seemed to be a routine game contract. There were, however, warning signs in the auction, so Fred took more than his usual care and was rewarded.

The ♣J opening lead was ducked and South continued with the ♣9 to North's ♣Q. North continued with the ♣2, as Hamilton ruffed with the ♥Q and South discarded a diamond (a spade would have worked out better, as the cards lay).

Hamilton cashed the ◆A and ruffed a diamond. He came back to his hand with the ♠K and led a spade to dummy's ace. He ruffed a spade, ruffed a diamond and ruffed the ♠J low.

Now he exited with the ♥J. South was forced to win his king and return a heart away from his 10. The endplay produced 10 tricks and plus 420.
