# Harry Lampert

Harry Lampert, a noted cartoonist who retired in 1976 and built a second career as a bridge writer and teacher, died Nov. 13 at Boca Community Hospital in Boca Raton FL. He was 88. The cause of death was a cerebral hemorrhage, his family said.

Lampert entered the cartoon field in 1933 where he did inking for cartoons including Popeye, Betty Boop and Koko the Clown. He drew the initial Golden Age character and DC comic book, The Flash #1, which appeared in January 1940.

Breaking into the gag cartoon field, Lampert wrote and drew cartoons that appeared in Time, Esquire, The New York Times, Saturday Evening Post and Saturday Review.

He founded The Lampert Agency, a New York City-based advertising and communications agency with clients including Olympic Airways, Hanes Hosiery, Seagram, the Netherlands and the U.S. Virgin Islands. The agency won the Cannes Film Festival Golden Lion Award for the World's Best TV Commercial in 1967.

Lampert retired in 1976 and started a new career: teaching and writing about bridge. His book, A Fun Way to Advanced Bridge, was named "Bridge Book of the Year" in 1985 by the American Bridge Teachers' Association. He served as ABTA president from 1991 until 1993 and twice won the ABTA's Apple Basket Award for the best teaching tip.

He was a regular columnist for The Bridge Bulletin. Lampert was a Bronze Life Master.

He and Adele, his wife of 62 years, divided their time between Deerfield Beach FL and Lenox MA. Other survivors are a daughter, Karen Akavan of Plainview NY, and two grandsons, Michael and Jeffrey Akavan.

# Seniors win gold in World Games

Led by a Senior team and Zia Mahmood, the USA scored several medals during the world championships in Istanbul, Turkey. The tournament concluded Nov. 6.

With a big final-round victory over Denmark, USA went from second to first in the 2nd International Senior Cup. The team was John Onstott, Jim Robison, John Schermer, Neil Chambers, Marshall Miles and Leo Bell. Gene Freed was non-playing captain. The format was a complete round-robin with no knockout phase.

In the Women's series of the 12th World Bridge Olympiad, the USA dropped a close decision to Russia in the final to earn the silver medal. The team was Marinesa Letizia, Jill Meyers, Randi Montin, Janice Seamon-Molson, Tobi Sokolow and Carlyn Steiner. Jill Levin was npc.

Zia earned a gold medal and his first world championship as a member of the winning squad in the 3rd Transnational Mixed Teams. He played with Sabine Auken of Germany and the French pair of Paul Chemla and Catherine D'Ovidio. They defeated Bulgaria in the final.

In the 2nd World University Teams Championship, USA finished behind Poland and Belgium in the 15-team event. The bronze medalists are Joon Pahk, Noble Shore, Marc Glickman, Ari Greenberg, John Kranyak and Charlie Garrod.

## Peter Mollemet

Longtime ACBL employee Peter Mollemet died of heart failure Nov. 18 in Memphis. The 61-year-old Mollemet, who had battled heart problems for years, arrived for work at ACBL Headquarters Thursday morning complaining of shortness of breath. He was taken to a Memphis-area hospital, where he died shortly thereafter.

#### **Today is Peter Mollemet Day**

The unexpected death sent shock waves through the ACBL family, particularly in the office at Memphis, where Mollemet was well liked for his dry wit and easy-going manner.

Headquarters staffers Rena Hetzer and Carol Robertson were both close friends of Mollemet. "Peter was so smart and so funny, just a joy to be around. He was always ready with a zinger. I'll miss his impish humor," said Hetzer. Robertson added, "I am going to miss Peter Mollemet so much. I've never had a friend like him. He was always there when I needed him. Peter loved helping people, especially in the bridge world. He is going to be missed in many ways. Thank you, Peter, for being my friend."

Mollemet was best known to ACBL members for his decades of service as a tournament director, especially in District 5 (western New York state and Pennsylvania, northeast Ohio and northern West Virginia). His directing career began in 1975. He achieved the rank of National Tournament Director in 1988 and was the area field representative for Districts 2, 4, 5, 11 and 12. Mollemet's role with the ACBL changed in March 2001, when he relocated to Memphis from his native New York to become the Internet Services manager. # LM Open Pairs: Trophy honors Nail

Jo Morse and Kyle Larsen won their first North American championship together when they captured the four-session Bobby Nail Life Master Open Pairs last year in New Orleans.

Morse and Larsen have been playing together since the Fall NABC in Birmingham in 2002. Both are Grand Life Masters who have won multiple North American championships. In addition, each has a world title: Morse won the World Mixed Teams in 1974 and Larsen won the Bermuda Bowl in Paris in 2001.

This event was for men only until 1990 when it became an open event.

Nail (1925-95) won this event in 1974 with longtime friend and partner Gerald Michaud.

Nail, inducted into the Bridge Hall of Fame at the 2001 Summer NABC in Toronto, won four other North American championships and represented North America twice in the Bermuda Bowl. His team was second in 1963.

# Bid Box Alerts and Announcements

When using bid boxes, ACBL suggests that players tap the Alert strip and say "Alert" at the same time.

When making an Announcement, use the Announcement word — such as "transfer" — and tap the Alert strip at the same time.

A player who Alerts or Announces a bid should make sure his opponents are aware that an Alert or announcement has been made.

### LM Women's recalls Helen Sobel Smith

The Helen Sobel Smith Trophy is the prize in the four-session Life Master Women's Pairs.

The trophy recognizes Helen Sobel Smith, universally considered the best woman player of all time and the first woman elected to the Bridge Hall of Fame .

She won 35 North American titles including two Vanderbilts, five Spingolds and four Reisingers. She won the McKenney Trophy (now the Barry Crane Top 500) three times: in 1941, 1942 and 1944.

When Smith died of cancer in 1969, the Bridge Bulletin remembered her as a player "without a peer among women and very few peers among men. Helen played like a man, it was true. But she also played like a lady."

Each player must have an ACBL convention card filled out and on the table. Please note that other types of convention cards, such as the WBF convention card or homemade cards that do not sufficiently resemble the ACBL convention card, are not acceptable substitutes.

### Glossary of bridge terms

New members of ACBL are often confused by the array of terms they hear: knockout teams, red points, rookie. Here's a list of terms and their meanings:

**Knockout Teams:** an event in which a team (of four, five or six players — with four playing at a time) plays another team. The losers are eliminated or "knocked out" while the winners play other winners until only one team remains undefeated.

The length of a KO match may vary from a single session to a full day (the Vanderbilt and Spingold) to a multi-day event (the Bermuda Bowl).

**Bracketed Knockout Teams:** a KO event in which teams are divided into groups — usually of 8, 16 or 32 teams — based on their masterpoint holdings. The top group — Bracket I — and all other groups compete in a separate event with their own set of winners.

**Compact Knockout Teams:** a shorter version of Bracketed KO teams.

**Swiss Teams:** an event in which a team (of four, five or six players — with four playing at a time) plays other teams in seven-, eight- or nine-board matches. Team A sits North-South at Table 1 and East-West at Table 2 while Team B sits East-West at Table 1 and North-South at Table 2. The results are compared and scored by International Match Points (IMPs).

Pairings for the first round are random. Pairings for succeeding rounds are determined by a team's win-loss record or Victory Point total.

International Match Points (IMPs): the most common method of scoring Swiss Team matches. If Team A scores plus 620 for bidding and making 4 on Board 4 and Team B scores only plus 170 (they didn't bid the game), the difference is 450 — which converts to 10 IMPs. The IMP chart is shown on the inside of your convention card.

Victory Points (VPs): a method of scoring Swiss Team matches. After the scores are compared and converted to IMPs, the IMP total is converted to Victory Points. A team's VP total may be used to determine its next opponent and its final standing.

**Side Game Series:** single-session pair games that pay red points. The Morning Side Game Series I, for example, is played at 9 a.m. the first Friday, Saturday and Sunday of each NABC. Pairs may play in one, two or three sessions. You must play in at least two sessions to be eligible for overall gold points.

**Flighted pairs:** When flighting is used, the field is divided by expertise or experience or both into several separate games. Flight A — "unlimited masterpoints" — is open to all players while the remaining flights are limited. Flight B might be 0-500 MPs or 0-1000 MPs while Flight C might be 0-300 or 0-500.

Each flight is scored individually, and masterpoint awards are made for each flight.

The masterpoint holdings of the players determine their flight. If one player is an expert while his partner is new to the game, the pair must compete in Flight A if the expert has a lot of masterpoints.

In flighted events, you may play up but not down. That means you may play in Flight A or Flight B even if your masterpoint holding qualifies you for Flight C. Conversely, you may not play in Flight B or Flight C if you are a Flight A player.

**Stratified Pairs:** The idea is to compete against everyone but to be ranked only with your peers.

Each pair is assigned a stratum or "strat" based on the masterpoint holding of the partner with more masterpoints.

**Example:** A = 1500+ masterpoints; B = 500-1500 MPs; C = 0-500 MPs.

Thus, the most experienced players are placed in Strat A, intermediate players in Strat B and less experienced players in Strat C. Masterpoints are awarded for placings in all strats, but gold points are awarded only in A and B. The game proceeds normally — the difference comes when the scores are tabulated and ranked.

In a three-strat game, the scores are ranked three times. The first ranking is done as in a regular open game. These are the Strat A results.

If a B or C pair does well in this ranking, they receive full credit for that performance. It is not all that uncommon for a Strat C pair to place first overall, and they receive the full masterpoint award for that game.

Note: A pair is eligible for only one set of masterpoint awards and automatically receives the highest award.

The second ranking compares the scores of only the B and C pairs — the scores of the Strat A pairs are eliminated. Once again, if a C pair does well, they receive points for their finishing position in the Strat B results.

The third and final ranking compares the scores of only the C pairs — all the scores of the Strat A and B pairs are eliminated.

**Strati-flighted Pairs:** The top group plays in a game of their own — Flight A. The rest of the field in divided into strats and plays as in a regular stratified pairs.

A recent innovation has been stratifying within Flight A. Flight A-1 may be listed as 3000+ MPs while Flight A-2 (or Flight X) may be listed as 0-3000 MPs.

# Non-Life Master Pairs vie for Miles Trophy

A pair of Swedish visitors came to last year's North American Bridge Championships and took home an unusual souvenir: the trophy awarded to the winners of the Rufus L. "Skinny" Miles Jr. Non-Life Master Pairs.

Marie Berggren and Gunnar Gothbert scored 185.68 matchpoints, just enough to edge John Bondurant of Memphis and Paul Horn of Brandenton FL, who posted 181.24. Six was top on a board.

The Non-Life Master Pairs features two qualifying sessions, followed by a two-session final.

At stake is the trophy named for Rufus L. "Skinny" Miles Jr. (1907-1984) of Virginia Beach VA, ACBL president in 1950 and 1956. He was named ACBL Honorary Member in 1952.

Miles, an investment executive, was a member of many ACBL administrative committees for nearly two decades. He served as president of the Mid-Atlantic Bridge Conference and as non-playing captain of the North American Bermuda Bowl team in 1957 and of the U.S. team in the World Team Olympiad in 1960.

# Thinking Bridge- Part 1 By Eddie Kantar

**♦** 543 Dlr: West Vul: Both **♥** 8 6 ♦ 10842 **♣** 7 5 3 2 **♦** 8 7 ♥ K Q 10 9 5 4 ◆ A J 7 3 2 **♦** J 3 ♦ 9765 ♣ K 6 4 ♣ J 10 9 ♠ AKQJ1062 ♦ A K Q ♣ A Q 8 West North East South **2**♥ Pass **6** • **Pass** Pass **Pass** 

The opening lead is the ♥K. You (South) are declarer. Plan the play.

If you think that East's  $4 \checkmark$  bid is aggressive with so few high-card points, think again. It is a conservative jump. Holding a weak distributional hand with a good fit, facing a partner who is also weak, you know that opponents surely have a game and a likely slam.

At least jumping to  $4\Psi$  (down only one, by the way) takes away several levels of bidding that the opponents would like to use to determine whether they have game or slam.

What about South's leap to 6\(\Lambda\)? Conservative or aggressive? Well, it certainly isn't aggressive. All South needs to find in the North hand is the \(\Lambda\)J and 6\(\Lambda\) is cold. If he doesn't have it, that's his fault.

He biggest worry is that North has the K and A is cold.

On to the play: when holding a super powerful trump suit and a void in the suit the opponents have led, be very careful about ruffing with your lowest trump. That low trump can sometimes be used to get to dummy.

If you ruff the opening lead with any spade other than the 2, you make your contract. You draw trumps, cash the top diamonds and enter dummy with your carefully preserved ♠2 to discard a club on the ♠10. The club finesse loses, but who cares? You have bid and made a vulnerable slam.

Now try making this contract if you ruff the opening lead with the \$2.

Points to remember:

- 1. With a big fit for partner's major suit plus wild distribution (preferably a singleton or void), jump in partner's suit, usually to game. Just do it! You will either make your contract or it will be a good save.
- 2. When all you need to make game or slam is a stray jack or queen in partner's hand, bid it. Don't expect partner to know that's all you need.
- 3. When holding a massive trump suit, be reluctant to ruff with a low trump that might possibly serve as a late dummy entry. Amen.

Henry Cukoff: "My good friend Peter died today, the reason still unknown. As always, he had kept whatever was bothering him a secret. That was typical Peter. Despite the fact that no one did more for the players or his fellow tournament directors, he always kept his true feelings under that seemingly impenetrable exterior.

"Well, the rest of us won't have that problem. As more people learn of his passing, there will be an outpouring of affection for him. While he probably would have been shocked by all this attention, the rest of us certainly will not be."

# To players who live outside North America

Participation in the Kaplan Blue Ribbon Pairs is limited to those ACBL members who have earned a Blue Ribbon qualification (or for those members on the Lifetime Top 100 masterpoint list). Participation in the Life Master Open and Women's Pairs is restricted to ACBL members who have achieved the rank of Life Master.

Foreign players who do not meet these criteria, but feel they are otherwise eligible, must receive a waiver in writing prior to the commencement of these contests. #### It takes two

Each player is required to have a convention card filled out legibly and on the table throughout a session. Both cards of a partnership must be identical and include the first and last names of each member of the partnership.

If a director determines that neither player has a substantially completed card, the partnership may play only Class A conventions and may use only standard carding. This restriction may be lifted only at the beginning of a subsequent round after convention cards have been properly prepared and approved by the director. Further, the partnership will receive a 1/6 board matchpoint penalty for each board played, commencing with the next round and continuing until the restriction is lifted. In IMP team games, penalties shall be at the discretion of the director.

If the director determines the partnership has at least one substantially completed convention card but has not fully complied with ACBL regulations, the director may give warnings or assign such penalties as he deems appropriate under the circumstances.

The objective of these warnings and penalties is the encouragement of full compliance with ACBL regulations.



# Looking back: Orlando 1998

The last Orlando NABC, held in the fall of 1998, didn't set any attendance records but it produced some fascinating deals. Here are a few.

Doing the math

Bryan Maksymetz made a valuable overtrick on this deal from the first qualifying session of the Life Master Open Pairs.

East led the  $\mathbf{v}Q$  to declarer's ace and Maksymetz made his first good move by laying down the  $\mathbf{A}A$ . The fall of the  $\mathbf{A}Q$  persuaded him that East was 2-4-5-2.

Maksymetz cashed the ♠A and exited with a club to East's king. When East played the ♠Q, his hand counted out to 6 high-card points in the red suits and the ♣K Q.

To make up an opening bid, East needed the ♠Q, so Maksymetz laid down the ♠K and dropped the queen offside.

Converting the doubles

JoAnna and Lew Stansby posted a 68.5% game in the afternoon and followed with 58% in the evening to claim the Life Master Open Pairs by more than a board.

Reflecting on that huge first final session, Lew pointed to an unusual number of penalty doubles by his side that resulted in lots of matchpoints.

Lew converted JoAnna's responsive double because of the quick tricks in his hand, plus the good possibility that JoAnna could get a heart ruff (she would have raised hearts had she held more than two).

JoAnna did indeed get a heart ruff. Combined

with three diamond tricks and the ♣A, the result was plus 300 and 71.55 out of 77 matchpoints.

Four boards later, Lew converted another one of JoAnna's doubles.

Lew acknowledged that it was a guess as to whether it was right to pass JoAnna's takeout double. "I thought it would be easier to defeat 3 \u22ac than to make 4 \u22ac."

In fact it would have taken a heart lead — unlikely on the auction — to defeat 4.

Lew's pass turned out to be inspired, however, and plus 300 earned his side 67 matchpoints.

\* \* \*

Rita Shugart became the first women since Helen Sobel Smith in 1957 to win the Reisinger Board-a-Match Teams.

Shugart and her international squad — Andrew Robson and Tony Forrester of England and Geir Helgemo of Norway — led the event after days one and two and after the first final session.

The team dropped out of first place afer the third of nine rounds in the second final session. For four more rounds, the Shugart squad hung in, staying in second place, less than a board behind the leaders. Shugart's team regained the lead after round seven, scored a near sweep in round eight and held on for the final three deals to eke out the win.

The turning point, Shugart said, was Board 13 in round five. Shugart and Robson were playing against Geoff Hampson and Eric Greco.

Hampson led the ♠A and continued with a spade to Shugart's king. She played the ♣K, taken by Hampson, who cleared the spade suit.

The key, obviously, was the diamond suit. Shugart was certain that Greco had the ♥A for his vulnerable two-level opener, so she had to find the ◆Q. If she guessed wrong and lost the lead, she was headed for minus 200 or worse.

After winning the AQ, Shugart cashed the AQ and overtook the A10 with dummy's jack. She cashed the A9, pitching a heart, and called for the A9 from dummy, convinced that Greco needed the A9 for his opener.

When the ◆J held, Shugart had 10 tricks and a win, since South at the other table went down in 2NT.

An extra trick


Give Steve Robinson a chance for an extra trick, and you can bet he will take it. In fact, he managed a club trick with the singleton \*Q opposite the \*J 9.

The deal occurred in the second qualifying session of the Mitchell Open Board-a-Match Teams. Robinson was playing with Peter Boyd.

East led a low heart, taken in dummy with the queen. Robinson played a spade to the queen, ace and 10. He followed with a diamond to the ace and a diamond ruff, spade to the 7 and a diamond ruff, spade to the 6 and a third diamond ruff — extracting all the opponents' diamonds. Robinson then ran trumps, reaching this position:



Robinson led the \$2 and East, who could see an endplay looming, discarded the \$A. If East had thrown his low club, Robinson would have had an easy endplay with the \$Q, forcing a heart return into Robinson's tenace.

When East unblocked clubs, Robinson cashed the ♥A, removing West's 7, and played the ♣Q. West won with the ♣K but had only the ♣10 left to play to dummy's good jack.

Plus 680 was good for a win.


