Also, we note that the EOC's assumption that "deducting masterpoints might put Mr. Gao in a lower masterpoint stratum" (EOC Narrative Decision, p. 20) is incorrect as a matter of ACBL regulation, as CDR 4.1.8(e) states that "Management shall assign Eligibility Points to equal the number of masterpoints that have been forfeited by the Disciplinary Body's decision."
