COMMITTEE FINDINGS OF FACT (based on the evidence, state the committee’s conclusion as to what happened)

In the Matter of Delbert and Ella Haylock, the Committee upheld the finding of the OEOC Panel that they violated CDR 301 (A)(2) Collusive Cheating Online. The committee upheld the suspension and probation imposed by the OEOC Panel but modified the terms of probation and the Masterpoint forfeiture provisions. Accordingly, they will both be Suspended for two years, followed by a three year probationary period. They will not be allowed to play together during the first year of their probationary period. Mr. Haylock will forfeit twenty five percent of his Masterpoint holding and Mrs. Haylock will forfeit twenty percent of her Masterpoint holding. They will be Members “Not in Good Standing” during the length of their Probationary period.
