COMMITTEE FINDINGS OF FACT (based on the evidence, state the committee’s conclusion as to what happened)

In the Matter of Denis and Betty Taneri, the Committee upheld the finding of the OEOC Panel that they violated CDR 3.20 Cheating and other Ethical Violations (CDR effective March 1, 2015).

The Committee modified the discipline imposed by the OEOC panel and clarified terms of probation. Accordingly, Mr. and Ms. Taneri will each be suspended for a period of two years beginning April 27, 2023. Each will serve a period of five years probation following their suspension, a condition of which is they are prohibited from playing with each other in ACBL sanctioned games during the first three years of the probationary period. Each will forfeit 25% of their total Masterpoint® holding. They will be members “Not in Good Standing” during the period of their discipline.
