SUMMARY OF REVIEW:

The Panel reviewed the following documents: Negotiated Resolution dated March 25, 2024, membership profile, Ethics Certification and Fair Play Pledge, and Notice of Intent to Initiate Arbitration before the IBA.

The Panel approved the Negotiated Resolution agreed to by the party and ACBL Management, in which Ms. Bernstein admitted to a violation of CDR 301(A)(2): Collusive Cheating Online (CDR effective February 1, 2024). Ms. Bernstein agreed to a penalty of 18 months' suspension beginning March 6, 2024, followed by 2 years' probation during which she is prohibited from playing in ACBL sanctioned online games with Joan Phillips and Melinda Dahlman during the first year of her probationary period, and forfeiture of 10% of his current Masterpoint total. She will be a member "Not in Good Standing."
