SUMMARY OF REVIEW:

The Panel reviewed the following documents: Negotiated Resolution, Membership Profile, Ethics Certification and Fair Play Pledge, and Notice of Intent to Initiate Arbitration before the IBA.

The Panel approved the Negotiated Resolution agreed to by the party and ACBL Management, in which Ms. Rosenberg admitted to a violation of CDR 301(A)(2): Collusive Cheating Online (CDR effective February 1, 2024). The discipline imposed is listed on page 2 of this report.



ADMISSION OF VIOLATION:

My infraction occurred as a result of loneliness and isolation resulting from the Covid Pandemic. I played online with Andrew Rosenberg, Susan Glazer, and Randee Braslow. I thought of our sharing hand information as personal connection and an opportunity to improve our bridge play. I realize NOW that this was improper and the wrong thing to do, and I will NEVER do this again. I never had an intention to cheat—just to maintain connection with my bridge colleagues. I truly regret what has happened, and I never meant to cheat or be untruthful. My infractions occurred on BBO only.
