**SUMMARY OF REVIEW:**

The Panel reviewed the following documents: Negotiated Resolution, Membership Profile, Ethics Certification and Fair Play Pledge, and Notice of Intent to Initiate Arbitration before the IBA.

The Panel approved the Negotiated Resolution agreed to by the party and ACBL Management, in which Mr. Braslow admitted to a violation of CDR 301(A)(2): Collusive Cheating Online (CDR effective February 1, 2024). The discipline imposed is listed on page 2 of this report.



**ADMISSION OF VIOLATION:**

I wish to expeditiously resolve the matter of the charge of Collusive Cheating Online.

The following is my admission of responsibility.

I played online with my wife, Randee Braslow (ACBL #: 3232468).

Over the years we played together, there were occasions when we did exchange confidential information. Generally I tried to avoid sharing hand information and not to let any information affect my decisions. Many of the hands cited by EDGAR seem to be a reflection of my own limitations and errors. Unfortunately some of this information did ultimately affect my decisions.

I did not stop to consider the serious consequences of sharing hand information, to myself, other players, the ACBL, and the game itself. I did not mean to bring harm to anyone or to dishonor the game or to place other players at a disadvantage. Certainly there was no malicious intent.

I am embarrassed and deeply regret my actions.  
 I feel I have inadvertently undermined my own integrity in the process.  
 This will never happen again.

I fully understand the charges and the punishment imposed by the ACBL.
