SUMMARY OF REVIEW:

The Panel reviewed the following documents: Negotiated Resolution, Membership Profile, Ethics Certification and Fair Play Pledge, and Notice of Intent to Initiate Arbitration before the IBA.

The Panel approved the Negotiated Resolution agreed to by the party and ACBL Management, in which Ms. Braslow admitted to a violation of CDR 301(A)(2): Collusive Cheating Online (CDR effective February 1, 2024). The discipline imposed is listed on page 2 of this report.
